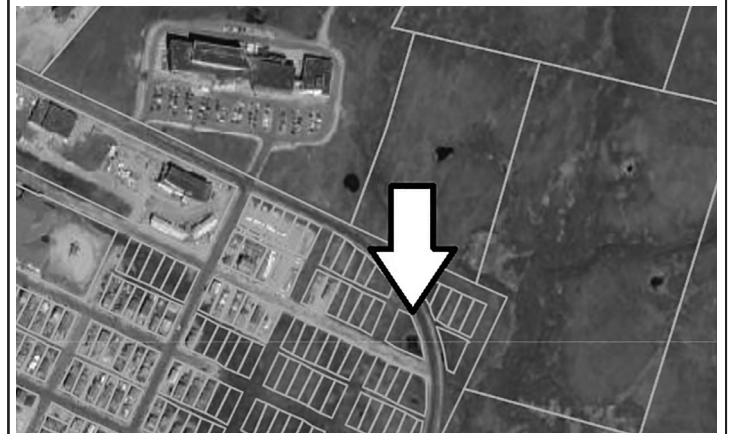

Special prosecutor charges former Alaska attorney general nominee with sexual abuse of a minor

A special prosecutor on Friday charged former Alaska Attorney General-designee Ed Sniffen with three counts of third-degree sexual abuse of a minor.

Third-degree sexual abuse of a minor is a Class C felony punishable by two to 12 years in prison.

The charges were not initially available to the public, but Deputy Attorney General Cori Mills provided the details in an email to Alaska Department of Law staff. On Friday, the Anchorage Daily News and ProPublica published copies of the charges.

"Now that charges have been filed," Mills wrote, "a grand jury will determine whether to indict based on the evidence presented to them."

She added that the charging decision was made by special prosecutor Gregg Olson, "and all other prosecutorial actions in this case will likewise be handled by the special prosecutor." Reached by phone, Olson confirmed the information in the email but said he could not provide further details until the case has been processed and entered by the court system. As of Friday evening, Alaska's online court database, CourtView, did not list the new charges against Sniffen.

The charges are related to Sniffen's alleged sexual relationship with a 17-year-old girl in 1991, when she was a high school student and Sniffen was the coach of her school's mock trial team. Sniffen was 27-years-old at the time.

The relationship came to light in


early 2021 after an investigation by the Anchorage Daily News and ProPublica.

At that time, Gov. Mike Dunleavy had named Sniffen his preferred replacement for Attorney General Kevin Clarkson, who resigned after a different ADN investigation found he had sent hundreds of unwanted text messages to a subordinate.

Sniffen, who was never confirmed by the Alaska Legislature, had been a longtime employee of the Department of Law, joining the agency in 2000 and working in a variety of roles until his departure.

According to the charging documents, Sniffen had sex with the 17-year-old on multiple occasions starting in May 1991 and continuing

Cheeseburgers



Recipe courtesy of Omaha Steaks Executive Chef David Rose

- 1 pound Omaha Steaks Premium Ground Beef salt, to taste
- freshly ground black pepper, to taste
- 2 tablespoons unsalted butter, at room temperature
- 2 brioche buns
- 2 slices yellow cheddar cheese
- 3 leaves romaine lettuce, shredded

Using thumb, make dimple in center of each patty to help cook evenly.

Season both sides of burger with salt and pepper, to taste. Spread butter on each cut-side of buns.

Grill burgers 4-5 minutes per side for medium doneness.

Add one slice cheddar cheese on each burger, close lid and grill about 30 seconds to melt cheese. Remove patties from grill to clean plate. Place buns cut-sides down on grill grates and toast 20-30 seconds, or until well toasted, being careful to avoid burning.

To make cheeseburgers: Preheat grill to 450 F using direct heat. Form ground beef into two 1/2-pound patties, each about 1/2-inch thick.

after her 18th birthday. The documents, based on an Anchorage Police Department investigation, state that Sniffen and the woman continued their relationship until February 1993.

Attorney Caitlin Shortell, representing the woman in the alleged relationship, said she had no comment Friday and that the woman was unavailable for an interview.

Sniffen has been represented by attorney Jeffrey Robinson, who did not immediately answer a message left at his office.

In Mills' letter to Department of Law employees, she said Sniffen worked alongside people at the department for many years.

"He was a valued colleague and to many of us, a friend," she wrote. "Today's filing of charges may be disappointing and even discouraging, but our department serves all the people of Alaska and is committed to fairness and justice for everyone."

They also test for SARS-CoV-2, the virus that causes COVID-19.

They pull out one whisker, usually the longest on the left side, shave a little bit of hair, collect scat if they can find it, and use an ultrasound to measure blubber thickness. They also tested for Influenza A, an avian flu, which has been found in harbor seals before.

These results are still being processed. Ziel explained that the data they gather also inform other projects that look at pathogens or contaminant exposure. These efforts helped

a 2016 study on Harmful Algal Blooms. Results in 2020 also showed that between 2007 and 2018, ribbon seals of all ages and sexes showed a decline in body condition, and spotted seal pups similarly had declining body conditions. There are clear trends in the decline, but Ziel said that researchers are still looking to explain exactly why.

Finally, Cameron talked about the new efforts to use drones to estimate mass and length of seals. This spring was supposed to be an opportunity to field test the models they had been building with the Long Marine Lab and the Alaska SeaLife Center, but weather and the conditions at sea

made launching the drone more difficult than expected. When the weather finally cooperated, however, they couldn't find many seals. "We did not get a lot of seal data on this cruise, so we used our statistician," Cameron explained, showing a picture of a man making snow angels on an ice floe. The exercise was "especially useful for testing, practice, and getting sensors dialed in," such as the laser range finder, said London. Cameron added that it's great to have statisticians in the field with them, not least because they can show how hard it is to get data.
