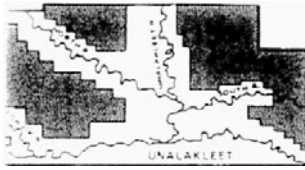

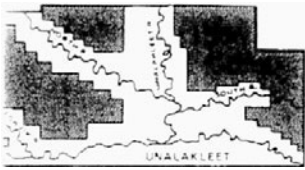

The Fisheries Biologist supervises Norton Sound Fisheries Technician Crew Leaders and seasonal work crews. A bachelor's degree in biological science and 2 years of fisheries research and management project experience or a master's degree in biological science is required.
